# **Terms and Conditions**

- 1. These terms and conditions apply to participants of the 'BANGN BODY GIFT WITH PURCHASE' Centre Offer ("Offer"). Participation in this Offer is deemed acceptance of these Terms and Conditions.
- The "Promoter" is Dexus Shopping Centres Pty Ltd (ABN 13 001 595 955). The address is 322 Moggill Rd, Indooroopilly QLD 4068.
- This Offer will be conducted at Indooroopilly Shopping Centre, 322 Moggill Road, Indooroopilly QLD 4068, 07 3378 4022 ("Centre").

# ELIGIBILITY

- 4. This Offer is only open to residents of Qld aged 14 years or over who are able to attend the Centre between 10am to 4pm AEST on Saturday 7 and Sunday 8 September 2024 to claim their Gift.
- 5. The following individuals are ineligible to participate in the Offer:

### **OFFER PERIOD**

### **CLAIM INSTRUCTIONS**

- 27. If this Offer is interfered with or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right to the fullest extent permitted by law to (a) disqualify a participant engaging in unauthorised intervention or fraud; or (b) to modify, suspend, terminate or cancel the Offer, as appropriate and if applicable, subject to any written directions from a regulatory authority.

If any dispute arises concerning the conduct of this Offer, the Promoter will take reasonable steps to consider your point of view, taking into account any facts or evidence you put forward, and to respond to it fairly within a reasonable time. - 35. The Promoter (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Offer, including without limitation:
  - a. any technical difficulties or equipment malfunction;
  - b. any theft, unauthorised access or third party interference;
  - c. any claim or correspondence that is late, lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter;
  - d. any variation in the gift value to that stated in these Terms and Conditions;
  - e. any tax liability incurred by a participant; or

# PRIVACY

- 37. In order to conduct this Offer, the Promoter needs to collect personal information about each participant and may for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, gift suppliers and, if required, to Australian regulatory authorities. - 38.
