INDOOROOPILLY SHOPPING CENTRE / BLACK FRIDAY UBER VOUCHERS Terms and Conditions

ELIGIBILITY

 - Click the payment option at the bottom and in the voucher section enter the Uber voucher code provided via the Indooroopilly website.
 - If the total Uber fare is more than \$50 (fifty dollars) the customer will be required to pay the difference.
 - There is a limit of one (1) free ride per eligible customer during the Promotion Period.
- **7.** It is a condition of entering the Promotion that entrants agree for their personal information to be added to the Promoter's database and to be used in accordance with the purposes set out in these Terms and Conditions.

LIMITS ON ENTRY

- 8. Only 1 (one) Uber ride to the value of \$50, per person during the Promotion Period may be redeemed.

- **21.** If there is a dispute as to the identity of the entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
