INDOOROOPILLY SHOPPING CENTRE / WALTER TAYLOR CLOSURE UBER GWP

Terms and Conditions

- 1. These terms and conditions apply to participants of the 'Walter Taylor Closure Uber GWP' Centre Offer ("Offer"). Participation in this Offer is deemed acceptance of these Terms and Conditions.
- 2. The "Promoter" is Dexus Shopping Centres Pty Ltd (ABN 13 001 595 955). The address is 322 Moggill Rd, Indooroopilly QLD 4068.
- 3. This Offer will be conducted at Indooroopilly Shopping Centre, 322 Moggill Road Indooroopilly QLD 4068, 07 3378 4022 ("Centre").

ELIGIBILITY

- 4. This Offer is only open to residents of Sherwood 4075, Graceville 4075, Chelmer 4068, Corinda 4075, Seventeen Mile Rocks 4073 and Oxley 4075, Tennyson 4105, Yeerongpilly 4105, Yeronga 4104, Fairfield 4103 QLD, aged 18 years or over who are able to attend the Centre between Saturday 14 and Sunday 29 September 2024, during Centre trading hours (Monday Wednesday and Friday 9am 5:30pm, Thursday 9am 9pm, Saturday 9am 5pm and Sunday 10am 4pm AEST) to claim their Offer.
- 5. The following individuals are ineligible to participate in the Offer:
 - employees, directors, officers and management of the Promoter, any related bodies corporate of the Promoter, or any of the tenants or retailers in the participating Centre/s or any of the Promoter's agencies that are associated with the Offer;
 - b. the spouse, de facto spouse, parent, child or sibling of an individual listed in paragraph a.; and
 - c. any person who the Promoter has previously notified is not permitted to participate in the Promoter's offers.

OFFER PERIOD

6. This Offer commences at 9am AEST on Saturday 14 September and ends at 4pm AEST on Sunday 29 September 2024 or until gift stocks run out (whichever is first) ("Offer Period").

CLAIM INSTRUCTIONS

- 7. To claim, eligible individuals must, during the Offer Period:
 - a. Spend \$500 or more at any store at Indooroopilly Shopping Centre during the Offer period ("Qualifying Spend").
 - b. Present your Qualifying Spend receipts to a staff member to be stamped at the Customer Service desk on level 2 during centre trading hours (Monday Wednesday and Friday 9am 5:30pm, Thursday 9am 9pm, Saturday 9am 5pm and Sunday 10am 4pm AEST).
 - c. Mention the offer to collect your Uber code for a free return Uber ride home upon successful validation of your claim.
 - d. To facilitate the collection of the offer, successful claimants will need to show official ID as proof of residing suburb. Please note, utility bills will not be accepted as proof of residence. Successful claimants will also need to provide their first name, last name and postcode.
 - e. Once you have received the Uber voucher code, download the Uber app and enter the destination of your trip (your return trip destination).

- Click the payment option at the bottom and in the voucher section enter the Uber voucher code provided via the Customer Service desk.
- f. If the total Uber fare is more than \$75 (seventy-five dollars) the customer will be required to pay the difference.
- 8. For clarity, the \$500 total spend can be made up of a maximum of five receipts from one or more participating retailers to comprise your Qualifying Spend and must be claimed the same day as the date on the Qualifying Spend receipts.
- 9. The following receipts are not accepted as part of this Offer:
 - a. Receipts from the purchase of alcohol, tobacco, lottery tickets or gift cards; and
 - b. Receipts from the purchase of goods or services which have subsequently been refunded before you have completed your claim.
 - c. Receipts using After Pay, Klarna, Zip Pay or purchases made via a similar service are not accepted as part of this Promotion.

CLAIM LIMITS

- 11. Each claim must be submitted separately in accordance with these Terms and Conditions. For clarity, you cannot use the same Qualifying Spend receipts for multiple claims.

- 12. A total gift pool valued at up to \$10,000 of Uber vouchers will be available to be redeemed during the promotional period.
- 13. The gift is one (1) return Uber ride of a residence within Sherwood 4075, Graceville 4075, Chelmer 4068, Corinda 4075, Seventeen Mile Rocks 4073 and Oxley 4075, Tennyson, Yeerongpilly 4105, Yeronga 4104, Fairfield 4103 to the value of up to \$75 (seventy-five dollars) and can only be used when the Uber driver can pick up the claimant from within a 0.4km radius of 322 Moggill Road, Indooroopilly QLD 4068.
- 14. Any items as part of this promotion are not redeemable for cash or transferable and must be taken as offered.

PROOF OF PURCHASE

17. You must keep your Qualifying Spend itemised receipts as proof of purchase for each of your claims. Your Qualifying Spend receipts must clearly identify whether the Qualifying Spend was made, the products purchased (of which must be/comprise the Qualifying Spend) and the date of purchase (which must be

during the Offer Period, before you claim).

- 18. If you don't produce the above proof of purchase for each of your claims when asked, the Promoter may disqualify each of your claims and you will lose any right to a gift.
- 19. Proof of purchase must be identical to that provided by you with your claims.

- 31. - 39. The Promoter (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Offer, including without limitation:
 - a. any technical difficulties or equipment malfunction;
 - b. any theft, unauthorised access or third party interference;
 - c. any claim or correspondence that is late, lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter;
 - d. any variation in the gift value to that stated in these Terms and Conditions;

You provide your information to the Promoter and not to any social media platform. You completely release any relevant social media platforms from any and all liability.

PRIVACY

- 41. In order to conduct this Offer, the Promoter needs to collect personal information about each participant and may for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, gift suppliers and, if required, to Australian regulatory authorities.

- 42.
