

**GENERAL TERMS AND CONDITIONS
INDOOROOPILLY SHOPPING CENTRE**

GIFT CARD

1. These General Terms apply to all Indooroopilly Shopping Centre Gift Cards ("Gift Cards") issued by Indooroopilly Property Management Pty Ltd ABN 94 144 809 174 9 ("IPM"), Centre Management Office, Level 5, Indooroopilly Shopping Centre, 322 Moggill Road, Indooroopilly, Queensland 4068.
2. By purchasing a Gift Card, you are agreeing to these General Terms. Purchase or use of this Gift Card constitutes your acceptance of these General Terms. If you wish to allow another person to use this Gift Card, you may only do so if you first tell them that they are bound by these General Terms.
3. This Gift Card is redeemable for merchandise or services at participating retailers at Indooroopilly Shopping Centre. This Gift Card can be redeemed at participating retailers with EFTPOS facilities. Retailers without EFTPOS facilities are unable to accept this Gift Card. This Gift Card cannot be redeemed at any time when a participating retailer's EFTPOS system is offline for any reason. A full list of participating retailers can be found at the Information Desk, Level 2 and the Customer Service Centre, Level 1, Indooroopilly Shopping Centre.
4. A \$2.95 administration fee per card applies.
5. Gift Cards can be credited with any amount between \$10.00 and \$500.00. This Gift Card cannot be reloaded. No further value may be added to it.
6. This Gift Card is not redeemable for cash and cannot be used for the payment of credit or retailer accounts.
7. This Gift Card is partially redeemable and may be used on more than one occasion. It is the responsibility of the customer to use the full value before the expiry date. Cash will not be given for any unused balance.
8. This Gift Card is valid for twelve months from the date of issue, after which it expires. This Gift Card must be redeemed before the expiry date shown on the Gift Card. The Gift Card will be void and may not be redeemed after the expiry date, and any unused value at the expiry date will not be refunded or credited.
9. Purchases exceeding the Gift Card's available balance require the difference to be paid by other methods.
10. Each of the participating retailer's return policy applies when returning goods purchased with an Indooroopilly Shopping Centre Gift Card.
11. Defaced, mutilated, altered, lost or stolen Gift Cards will be void and will not be replaced, refunded or redeemed.

12. No variations of these General Terms bind us unless they have been approved and signed by IPM. Changes to these General Terms will be available on this Website and at the Information Desk, Level 2, Indooroopilly Shopping Centre.
13. Visit the Information Desk, Level 2 or the Customer Service Centre, Level 1, Indooroopilly Shopping Centre if you have any reason to believe that an error has occurred in relation to your Gift Card.
14. A customer can check their balance by phoning 1300 554 268 or by logging on to the Gift Card Website (<http://indooroopillyshopping.com.au/index.php?/gift-cards>).
15. IPM reserves the right to change any term contained in these General Terms where the change is required:
 - to add or remove participating retailers at which the Gift Card may be redeemed, or the goods and/or services which may be purchased using the Gift Card;
 - to comply with all relevant laws, acts, ordinances, rules, regulations, other delegated legislation, codes and the requirements and directions of any relevant Commonwealth, State or Local Government Departments, bodies and public authorities, in force from time to time;
 - for reasonable operational, administrative, compliance or corporate governance reasons, or to prevent the occurrence of fraud or other unlawful, unethical or unacceptable conduct; or
 - where IPM, acting reasonably, considers that it will not cause detriment to the customer.
16. IPM will not be liable for any damages, liabilities, expenses, fines or costs, nor be in breach of these General Terms, or for any failure to perform any terms if such performance is delayed, prevented, restricted or interfered with for any reason outside IPM's reasonable control, including but not limited to fire, flood, storm, earthquake, accident, war, acts of sabotage, labour dispute, materials or labour shortage (other than shortages of its own staff or staff under its control), system failure, power failure or shortage, law, regulation or act or omission of third persons.
17. These General Terms are governed by the law of Queensland and each party irrevocably and unconditionally submits to the non-exclusive jurisdiction of the courts of Queensland.
